# **Primary Responsibilities**

### • Strategic Leadership:

- Collaborate with the Executive Director of Operations to set facility strategy to ensure all church facilities are positioned, equipped, operated, utilized and maintained to support the church's mission and vision with a focus on maximizing the stewardship of spaces and places.
- Develop and articulate the strategic vision, strategies, and tactics for all facility departments and functions including maintenance, safety & security, events, strategic partnerships, etc... ensuring departments are aligned with the overall mission and vision of Cross Point Church.

#### • Team Leadership:

- Serve as a member of the Operations Leadership Team focused on bringing strategic solutions that help the Operations Team develop integrated strategies and enterprise solutions to support ministry teams
- Provide leadership and oversight for the facility maintenance and safety & security teams, with an emphasis on delivering excellent service and support to other ministry teams
- o Recruit, train, and develop team members and volunteers to ensure a high level of expertise, efficiency, innovation, and integrity.

#### Stewardship Management:

- o Carry responsibility for stewarding all the resources of the facility team, including funds, equipment, places, and people
- Oversee the creation and management of the operating and capital budgets for the facilities team with a focus on efficiency, effectiveness, and overall good stewardship

#### Facility Utilization:

- o Responsible for managing the overall use and utilization of all church facilities by ministry teams, 3rd parties, as well as local and strategic partners
- o Building systems and processes to increase space utilization and efficiency by identifying new opportunities and maximizing current uses

### Safety, Security, & Logistics

- Oversee the safety and security team to ensure our facilities are properly safeguarded and that our teams are trained and equipped for safety & security needs
- o Develop efficient facility storage solutions and processes for the efficient transportation of ministry equipment, supplies, and other materials.

#### Facility Maintenance

- o Oversee the facility maintenance team ensuring our facilities are well maintained and that maintenance issues are addressed efficiently and effectively
- O Develop with facilities team best practices for proactive facility maintenance and the adoption of the tools needed to manage successfully
- Assist facility maintenance team with major contracts and significant vendor relationships
- o Evaluate and provide project management capacity to major capital improvement projects, deferred maintenance repairs, and major replacements

- Leases, Events & Strategic Partnerships:
  - o Manage all facility leases, licenses, or other tenant relationships ensuring compliance and minimizing ministry interruptions
  - o Serve as primary liaison and point of contact with all strategic facility partners helping ensure the partnership is being maximized for kingdom impact
  - o Provide leadership, strategy, and structure for Cross Point hosted third party events focused on building a scalable and sustainable events model that helps advance our mission and vision
